



## Affidavit of Copyright Ownership or License

### DEFINITIONS

The band leader, corporate representative, label representative or individual client, etc. is referred to as the “**Client.**” The “**Client**” certifies that they are the copyright owner of any material that they are or will be recording at jFX Studio.

### COPYRIGHT TYPE

The “**Client**” is the:

- Copyright Owner**
- Mechanical Licensee**  
For re-recording or “covering” a song. This does not confer the right to reproduce an already existing sound recording.
- Sound Master Licensee**  
For using samples whose copyrights belong to others.

### INDEMNITY

For any material which the “**Client**” does not own the proper copyright to, they realize that they are fully responsible for acquiring the proper copyright from the copyright holder or pertinent rights organization, and that they release jFX Studio from any responsibility or liability concerning their licensing responsibilities, or from neglecting their licensing responsibilities.

### PROMOTIONS

jFX Studio may use “**Client**” works (or portions of them) as “demo” examples from time to time, showing off our best and latest work. This may take the form of a Web audio file or a demo CD audio file. Copyright will be cited whenever possible. No exclusive or non-exclusive license is granted to jFX Studio. jFX Studio will *NOT* attempt to profit from the exposition of “demo” works.

I do *NOT* want my work to be considered for a jFX Studio “demo” example.

jFX Studio may take digital photographs of the “**Clients**” in-session, for use in our Web site’s “News” section. A short news story generally accompanies any photos, similar to “‘**Client**’ records latest project at jFX Studio.’ To that end, I hereby give jFX Studio the right to publish or otherwise use my photographic likeness, in whole or in part, for promotional purposes.

I do *NOT* want my photo or likeness to be considered for a jFX Studio Web site “News” story.

I do *NOT* want jFX Studio to mention me now or ever in a jFX Studio Web site “News” story.
